VASAVI KUTUMBA SURAKSHA PADHAKAM (VKSP)

TERMS & CONDITIONS

1. The applicant shall be an enrolled member of VCI through any Vasavi Club as on 31.07.2013. (Except the Staff Members of VCI)
2. Non Refundable amount of Rs.1500/- [Rs.1000/- towards admission fee + Rs.500/- towards contingency liability account] to be paid to VCI.
3. The membership in the scheme will continue only when his/her annual subscription paid in time at their Home Club.
4. (a) All the existing Club members [majors] upto age 60 years as on 31-07-2013 are eligible to become the members of the scheme.
(b) New Club Members joined / joining from 01-08-2013, the age limit is restricted to 58 years. For such New Members the benefits of the scheme will be extended after completion of 24 months as VKSP Members, except for accidental deaths.
(c) However, the benefits of the scheme will be extended without any restrictions, if the age of New Member is 50 years or below at the time of joining as Member of the scheme. New members shall invariably remit Rs. 100/- (For Natural Deaths) or Rs.200/- (For Accidental Deaths) as the case maybe, per demise of each member from the date of joining itself.
(d) All the applicants of VKSP Scheme shall invariably submit documentary proof of their age such as (i) Pan Card, (ii) Driving Licence, (iii) School Certificate, etc.
5. All the members in the scheme (Including New Members) have to pay/remit a nominal amount of Rs. 100/- (For Natural Death) or Rs.200/- (For Accidental Death) each to VCI on receipt of intimation about the demise of any of the eligible scheme member. However each VKSP Member shall ensure to maintain atleast Rs.500/- in his/her contingent liability account at any point of time. If the member fails to remit said amount within 15 days from the date of intimation the respective scheme membership gets cancelled. If any such Vasavian wishes to continue the membership, he/she has to pay again Rs.1000/- to continue the privileges of membership.
6. The member shall appoint a nominee in the column given in the application. In case the given nominee expires before the death of the member, the member has to re-nominate a person by way of written communication to VCI.
7. (a) The scheme with present Membership of 3247 will automatically close on reaching 5000 membership on first come first served basis.
(b) The amount payable to the Nominee depends on the aggregate membership of the scheme as on the date of the decease of the member.
Ex: If 4000 members joins at the time of decease of VKSP member, the nominee of the deceased will get Rs.4 Lakhs.
(c) In case of accidental death, each member has to contribute Rs. 200/- each instead of Rs.100/- and amount payable to the Nominee of the deceased also enhances proportionately.
(d) Suicidal deaths are not eligible for any benefits of the scheme at any time.
(e) In case any member suppresses the health conditions at the time of entry in the scheme, found guilty on enquiry after demise, the benefits will be denied by VCI.
(f) VCI suggests all the members to get their spouse and all major children as the members of the scheme for easy acceptance and access into the scheme.
8. The committee constituted by the International President for the settlement of claims will scrutinise the claim application and only on their satisfaction the claim amount will be settled.
9. Accepting / Rejecting of any Application is subject to the discretion of VCI.
10. Any disputes arising in the scheme are subject to Hyderabad Jurisdiction only.
